Privacy Policy and Data Protection Statement

Privacy statement

The Confédération Européenne de Pétanque (CEP) web site does not store or capture personal information, but merely logs the user's IP address that is automatically recognised by the web server. We do not use cookies for collecting user information and we will not collect any information about you except that required for system administration of our web server.

Data Protection

The CEP is a privacy conscious organisation and is strongly committed to your right to privacy. That is why we have drafted this Privacy and Data Protection Statement, which follows guidelines set out in the General Data Protection Regulation (GDPR) 2018.

The General Data Protection Regulation

The GDPR set rules for processing personal information and applies to structured paper records as well as data held on computers (electronically stored data). The provisions of the GDPR will apply to all records, including those structured other than by reference to the data subject, and completely unstructured files.

CEP's Use and Storage of Data

The Data Protection Act states that those who record and process personal information must be open about how the information is used and must follow the eight principles of 'good information handling'.

These principles state that data must be:

- Fairly and lawfully processed
- Processed for limited purposes
- Adequate, relevant and not excessive
- Accurate
- Not kept for longer than is necessary
- Processed in line with your rights
- Secure, and
- Personal data will not be transferred outside the European Economic Area unless that country provides an adequate level of protection

By law, data controllers, including the CEP, have to keep to these principles.

How does the CEP collect data?

There are several means by which the CEP collects personally identifiable data, for example:

- Completion of a Board of Directors candidate nomination form
- Acceptance for inclusion on a mailing list or database
- For research, surveys or monitoring purposes
- By entering into email or telephone correspondence with a Board or Commission member of the CEP
- Through obtaining information for championship records

All personally identifiable information provided to the CEP is processed in accordance with the principles of the GDPR.

Is information passed to third parties?

The CEP will inform you, when it collects your data, who it may share your information with. Otherwise, it is the CEP's policy to disclose information to third parties only if explicitly required to do so by European Union (EU) Law or where your consent has been obtained in writing.

The CEP does not collect or compile personally identifying information for dissemination or sale to external parties for marketing purposes or host mailings on behalf of third parties, although the CEP may occasionally use your personal information to let you know about future championships, which may benefit your organisation and these communications or mailshots may be administered by third parties, such as a host Federation.

Your rights

Under the GDPR, you have various rights with respect to our use of your personal data:

Right to Access

You have the right to request a copy of the personal data that we hold about you by contacting us at the email or postal address given below. Please include with your request information that will enable us to verify your identity. We will respond within 1 month of a request.

Please note that there are exceptions to this right. We may be unable to make all information available to you if, for example, making the information available to you would reveal personal data about another individual, if we are legally prevented from disclosing such information, or if there is no basis for your request, or if it is deemed excessive.

Right to rectification

The CEP aims to keep your personal data accurate and complete. We encourage you to contact us using the contact details provided below to let us know if any of your personal data is not accurate or changes, so that we can keep your personal data up-to-date.

Right to erasure

You have the right to request the deletion of your personal data where, for the personal data are no longer necessary for the purposes for which they were collected, where you withdraw your consent to processing, where there is no overriding legitimate interest for us to continue to process your personal data, or your personal data has been unlawfully processed.

If you would like to request that your personal data is erased, please contact us using the contact details provided below.

Right to object

In certain circumstances, you have the right to object to the processing of your personal data where, for example, your personal data is being processed on the basis of legitimate interests and there is no overriding legitimate interest for us to continue to process your personal data, or if your data is being processed for direct marketing purposes. Right to restrict processing

In certain circumstances, you have the right to request that we restrict the further processing of your personal data. This right arises where, for example, you have queried the accuracy of the personal data we hold about you and we are verifying the information, you have objected to processing based on legitimate interests and we are considering whether there are any overriding legitimate interests, or the processing is unlawful and you elect that processing is restricted rather than deleted.
